## ACCEPTANCE OF LIABILITY AND RESPONSIBILITY FOR ADHERENCE TO THE ONE TREE HILL PROGRESS ASSOCIATION COVID-SAFE PLAN FOR THE ONE TREE HILL INSTITUTE

In signing this liability form I acknowledge that:

- a) the South Australian Government is regulating community activities in response to the COVID-19 pandemic through the issuing of Emergency Management Directives;
- b) I have read and agree to abide by the SA Government's Current Activity Restrictions that are published at <https://www.covid-19.sa.gov.au/restrictions-and-responsibilities/activities-and-gatherings/current-activity-restrictions>
- c) I have read and understood the One Tree Hill Progress Association Covid-Safe Plan that can be found at <https://onetreehill.org.au/index.php/hall> and that I agree to abide by the obligations contained in that Plan;
- d) I understand that the restrictions imposed by the SA Government's Current Activity Restrictions may restrict the:
  - i. number of people permitted at my event, including the number of people allowed in each room in the hall; and
  - ii. the types of activities at my event, including such things as fitness training, ceremonies, singing, dancing, the serving and consumption of food and/or drinks, the wearing of masks, the spacing of tables, etc;
- e) I will ensure that all persons entering the hall will either scan the contact tracing QR code or complete the written attendance record;
- f) I will encourage everyone to maintain the physical distancing principle of at least 1.5 metres separation where possible between groups within each room and at entry/exit points; and
- g) the requirements for a Covid Marshall (if applicable) will be met.

**Requirement for Covid Marshall.** A Covid Marshall is required where prescribed operations (as described in the SA Government's Emergency Management Directives) are conducted. Hall users conducting any of the prescribed operations must appoint a suitably qualified Covid Marshall to oversee the event in accordance with the Direction. A copy of the Covid Marshall training certificate must be given to the Hall Manager before the event begins.
